CONTINUING ED COMPLETION DATES <u>HAVE CHANGED</u>!!

The State has changed the mandatory completion dates for Continuing Education for Salespersons and Brokers to **3 MONTHS** <u>BEFORE</u> your license renewal in <u>2024</u>. This would mean CONTINUING EDUCATION MUST BE COMPLETED BY:

- February 28, 2024 for Salespersons Licenses (yearly renewals are in May each year) *Click Here for more information.*
- August 31, 2024 for Brokers Licenses (yearly renewals are in November each year)*Click Here for more information.*
