2024 CHANGES TO REAL ESTATE LICENSING LAWS

On April 1, 2024 revised real estate licensing and enforcement statutes become effective. The DCP has provided a summary of those changes, including, but not limited to, Associate Broker Classification, License Renewals, Late CE Completion, Team Registrations and Fair Housing Disclosures.

GATES SCHOLARSHIP - APPLICATIONS NOW AVAILABLE

2024 Raymond F. Gates, Jr. Memorial Scholarship applications are now available. **The application deadline is Wednesday, April 10.**

If you have a child/stepchild who is a high school senior or full-time college/vocational-technical/graduate student with at least 1 remaining term left to complete and you meet the membership requirements - they are eligible to apply. A few important things to note:

- Grandchildren are **not** eligible to apply unless the legal ward of the grandparents (documentation required).
- · When creating an account in the online application system, it must be in the name of the STUDENT, not the parent.
- · If you have previously created an online account, you do not need to create a new one. You can use your existing account to apply again this year, just be sure to check that the email on the account is up to date.
- · 2024 membership dues must be paid in full no later than 3/1/24 to be eligible.

CONTINUING EDUCATION REQUIREMENTS FOR BROKERS FOR THE 2024 RENEWAL

Every two years CT Real Estate brokers and agents must complete twelve (12) hours of continuing education to renew their CT real estate licenses. This year the 12 hours includes the mandatory class of **Agency Law for Real Estate Licensees** and 3 elective courses.

BROKER CONTINUING EDUCATION MUST BE COMPLETED BY:

 August 31, 2024 for Brokers Licenses (yearly renewals are in November each year)

The Greater Bridgeport Board of REALTORS is offering CE Classes for the 2024 Renewal Cycle, including the **Mandatory Agency Law for Real Estate Licensees**.

(Salespersons should have completed their CE Requirements before March 1, 2024 - and MUST be completed before their license expires in May 2024)

NAR MANDATORY CODE OF ETHICS REQUIREMENTS

ALL REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time within a **three-year cycle**. The current **Cycle 7 ends December 31, 2024**. Emails will be going out to remind our members that they need to complete this requirement. *Failure to comply with this NAR requirement can result in suspension of your membership.*
