Total Membership dues for 2025 for The Greater Bridgeport Board of REALTORS® will again be **\$626.00**. The breakdown for the Local,

State and National Dues is shown on your invoice and on the NAR eCommerce website.

#### **BROKER LICENSE RENEWAL:**

Broker licenses expire on November 30<sup>th</sup>. This year they will be renewed for 2 (two) years. The continuing education for 2024 was to be completed by August 31, 2024.

Cost – \$225.00 each class NO REFUNDS ONCE CLASSES ARE BOOKED

The Requirements were changed in 2022 and are as follows:

Be at least 18 years of age.

60-hour classroom course in Real Estate Principles and Practices.

15-hour classroom course in Real Estate Brokerage Principles and Practices.

15-hour classroom course in Legal Compliance.

#### Also:

Two (2) 15-hour pre-license elective courses OR one (1) 30-hr pre-license Appraisal/pre-license elective course OR 20 real estate transactions in the previous 5 years. A transaction is defined as a legal transfer of real estate property or execution of a lease agreement.

Actively engaged as a licensed real estate salesperson under the supervision of a licensed real estate broker in this state for at least 1,500 hours, including no less than 4 real estate transactions, during the three (3) years immediately preceding the date of application.

### NAR MANDATORY CODE OF ETHICS REQUIREMENTS

ALL REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time within a **three-year cycle**. The current Cycle 7 ends **December 31, 2024**.

We have been provided with a list of our members that do not have a Code of Ethics Class indicated in their record with NAR for this Cycle. GBBR will be emailing those members who are on the list. If you have completed a Code of Ethics Class since January 1, 2022, please forward a copy of your Certificate

If you need to complete a **COE Class**, the GBBR will be offering a zoom class on **Friday November 22nd. 2024 1:30pm to 4:30pm Cost is \$25.00**
